Brief Description of Major Duties: Rock Academy Preschool Teachers strive daily to bring the Living Word to students who do not, as of yet, have a personal relationship with Christ. We also work diligently to equip students who are saved, giving them the educational, spiritual, emotional and physical tools needed to become Christian leaders. Keep classrooms, playgrounds, resources, equipment, and physical environment clean, safe and presentable. Be able to effectively write and teach a weekly Lesson Plan with age appropriate activities for the age group served. Lesson Plans must be posted and a copy turned in weekly to the director. In addition, be able to supervise and work with each age group, from birth to 6 years if needed. Never use corporal punishment; never use abusive words, acts, or behavior towards any child, parent or staff member. (If found to have violated anyone's personal rights, it will be grounds for immediate termination.) Participate in The ROCK devotional readings, meetings, and/or other spiritual and educational helps required by the ROCK administrators. Be on time at the start of your shift, ready and prepared to begin your day. Exhibit an attitude that represents Jesus. Be sure that all areas you work in has supplies and is restocked as needed. Dress appropriately. (See Staff Handbook) Call when you are going to be absent due to illness or late, leave a message but always call back to confirm that your message was received. (Calls due to being late does not exempt you from P.C.'s depending on the circumstances.) Read, acknowledge and sign a receipt that they have knowledge of and understand what is expected of them in regard to their responsibilities, duties, and qualifications as an employee of The ROCK Academy as stated in the Job Description and Staff Handbook.

Qualifications & Requirements: Note: All units below are in regard to ECE. A teacher must know what is required in regard to Title 22 Chapter 12 of Community Care Licensing. 12 units in Early Childhood Education, 9 units and enrolled in 3 additional units, 6 units and enrolled in 3 units for the next 2 consecutive semesters until 12 units are completed. *FULLY QUALIFIED TEACHER: 12 units in ECE with 3 of the 12 units in Principles of Child Development and 3 of the 12 units in Child Family & Community. *(Qualifies to supervise an aide.)

To be considered for this position, outside applicants are required to complete Application for Employment; in-house applicants are to submit an updated resume. Employee's performance and attendance record will be taken into consideration at the time of the selection process. Selection for an interview does not guarantee promotion or appointment to the position. As part of the employment process, The Rock Church may obtain a Criminal Record Check.
