Position Summary: The Rockpile Bookstore seeks part time Sunday Retail Cashiers. The cashiers are responsible for maintaining operations of the cash wrap of the Rockpile Bookstore in a manner that will honor God. Cashiers report directly to the Retail Managers and are responsible for cash handling, sales and customer service, quickly serving customers in line and maintaining an accurate cash drawer. This includes, but is not limited to sales and customer service, accountability for the Rockpile financial performance, development of new business and incremental sales, adheres to policy and procedures, responsibility for overall location appearance, and general organization.

Job Responsibilities and Duties:

1. Assists store operations during business hours.
2. Ensure exceptional in-store experiences for our customers, building and maintaining relationships.
3. Ensures that the store is clean and organized and that merchandise is priced correctly.
4. Learn and instill the culture, organization, operations processes and policies at store level.

The above summary of duties represents the major tasks and duties. This is not intended to be an exhaustive list of all responsibilities. Therefore, the individual may perform other related tasks under the direction of the Retail Manager.
